For acceptance into the Music Education Program the student must (a) successfully complete all of the above course work for the first and second years with a grade of C or better in all music and music education course work, (b) have a cumulative grade point average of 2.5 or higher, (c) have a composite music education recommendation score of 11 or higher from the student's applied teacher, major conducted ensemble director, instrumental music education professor, music theory professor, and the undergraduate music coordinator, d) pass the music education jury, and e) jury to the 200 level on her/his applied instrument.
